**FURTHER THAT** the CAO be authorized and directed to send letters to the Complainants and the Respondents to identify the completion of the Third-Party Investigations and include the complete list of Third-Party Recommendations; and,

**FURTHER THAT** the Deputy Mayor and CAO will be the Town of Faro's authorized representatives for the purpose of responding to inquiries, including all Media inquiries on this matter.
